### Requirements

2. Applicant must be attending a post-secondary institution or training program during the 2019-2020 academic year.
3. Applicant must submit a completed application packet and demonstrate need for funds.

### Your application packet must include all of the following:

1. Scholarship application form.
2. Official academic transcripts for all high schools attended and/or post-secondary institutions if applicable.
3. Test Scores –Scholastic Aptitude Test (SAT) or American College Testing (ACT). If you are applying for a graduate program, please submit your GRE scores, if applicable. If you are a student who has not been in school recently and have no test scores, please type a note to explain your situation.
4. A one to two page essay describing your educational goals and plans for the future. Be sure to include any accomplishments (honors, awards, leadership and extracurricular school, civic or volunteer activities) and how they have prepared you for post-secondary education and life.
5. Verification of enrollment.

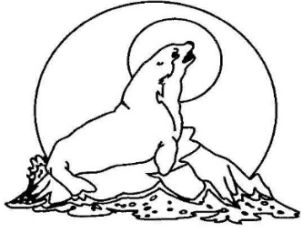
Include all pages together in the order given above. Incomplete applications will not be accepted. Failure to comply with any of the requirements will disqualify an application and the application will not be considered.
